ORDER

The Transport Commissioner, Chennai has stated that according to rule 366 of the Tamil Nadu Motor Vehicles Rules, 1989. Government are the competent authority to exempt any vehicle from all or any of the provisions of rules under the Chapter VII namely, Construction Equipment and maintenance of Motor Vehicle . The fee for such exemptions shall be as specified in the Table under rule 368. The present prescribed fee for seeking grant of exemption by Government in this regard, however, seems to be very low compared to the nature of services rendered by the Department/ Government. Taking all these aspects into consideration, Transport Commissioner has suggested that the Government may consider enhancing the present flat rate fee of Rs.300/- as detailed below:-

1	Stage Carriage (Except Stage Carriages owned by state Transport Undertaking), Omni buses. Heavy goods carriages and special type of vehicles such as “Construction Equipment Vehicles”)	Rs.10,000/-
2	Others	Rs. 2,000/-

2. The Government have examined the above proposal of the Transport Commissioner, Chennai and accept it. Accordingly, the Government have proposed to publish draft amendment to rule 368 of the Tamil Nadu Motor Vehicles Rules, 1989 as required under sub-section (1) of section 212 of the Motor Vehicles Act 1988 (Central Act, 59 of 1988).

3. The following Notification will be published in the Tamil Nadu government Gazette.

NOTIFICATION

The following draft of amendment of the Tamil Nadu Motor Vehicles Rules, 1989 which it is proposed to be made in exercise of the conferred by section 111 of the Motor Vehicles Act. 1988 (Central Act 1988), is hereby published for the information of all persons likely affected thereby, as required by sub-section (1) of section 212 of the section.

2. Notice is hereby given that the draft amendment will be take consideration on or after the expiry of the period of fifteen days from the date of publication of this Notification in the **Tamil Nadu Government Gazette** and that any objection or suggestions which may be received from any person with respect thereto before the date of expiry of the aforesaid period will be considered by the Government of Tamil Nadu.

3. Objection or suggestion, if any, should be addressed in duplicate to the Secretary to Government, Home Prohibition and Excise (Transport) Department, Chennai-600009.

DRAFT AMENDMENT

In the said Rules, in rule 368, in THE TABLE, for Serial No.4 in column (1) and the corresponding entries in columns (2), (3), (4) and (5) thereof, the following shall be substituted, namely:-

4. For granting exemption by Government

(A) Stage Carriage other than Stage Carriages owned by the Sate Transport Undertakings, Omni Buses, Heavy goods Carriages and special Type of vehicles such as "Construction equipment vehicles.	10,000	366
(B) Others	2,000	366
